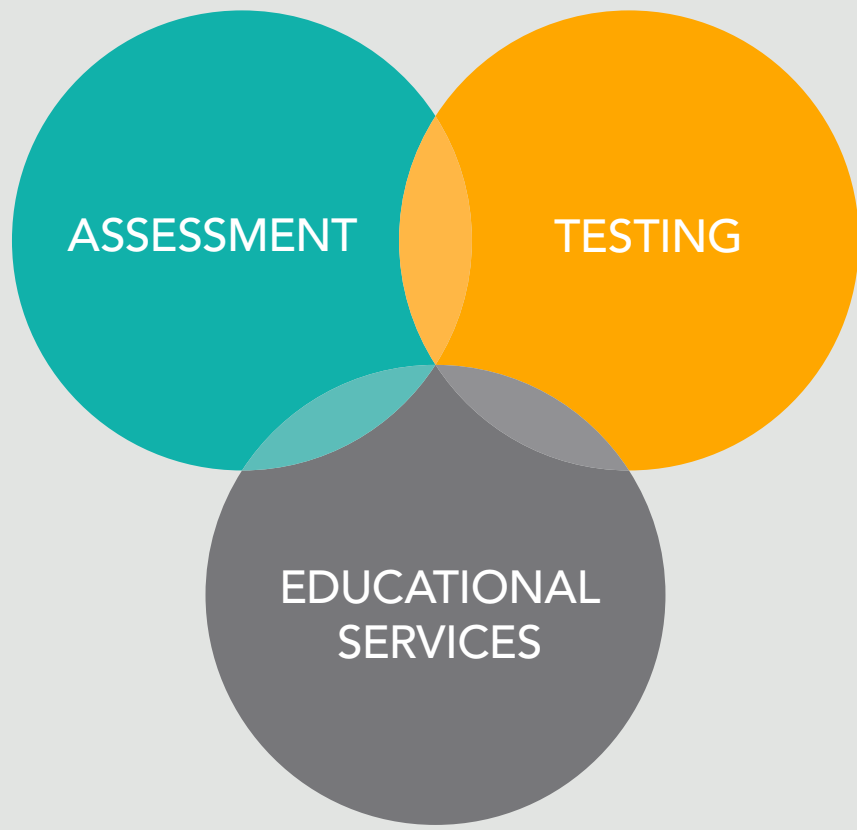
Our assessors have not only worked in the trades they assess, they also have qualifications to be assessors.

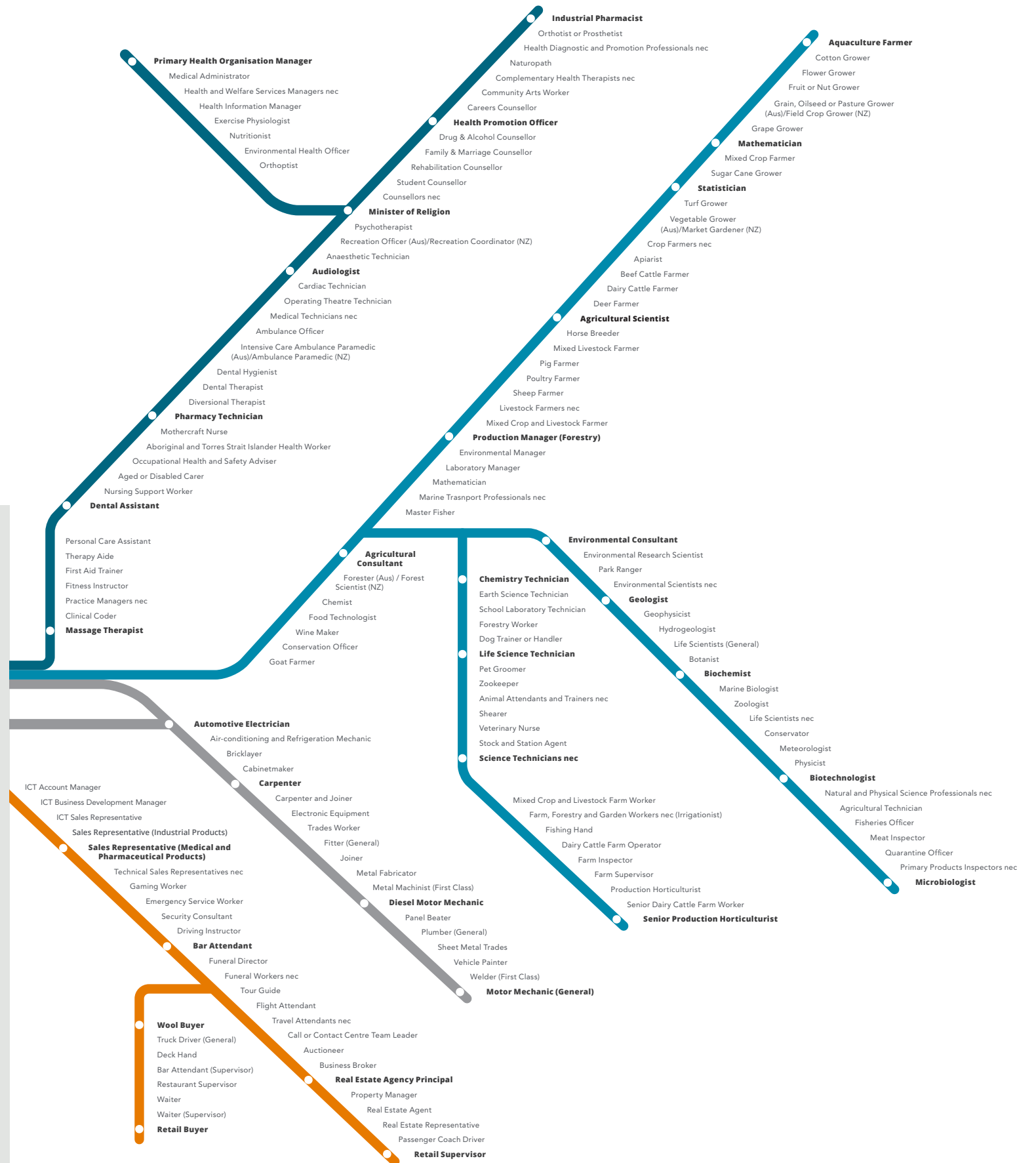
