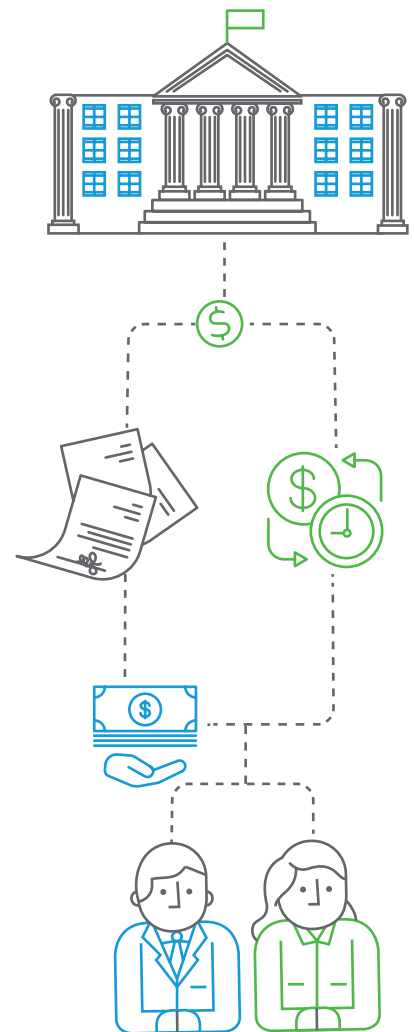

## Examples of success

**In-situ gasification project:** Prepared multiple funding applications for a remote South Australian ISG project, resulting in >\$10 million in Government funding.

**Advanced steel manufacturing:** Identified and coordinated a successful bid for Advanced Manufacturing funding to support the Northern Territory's metals processing precinct.

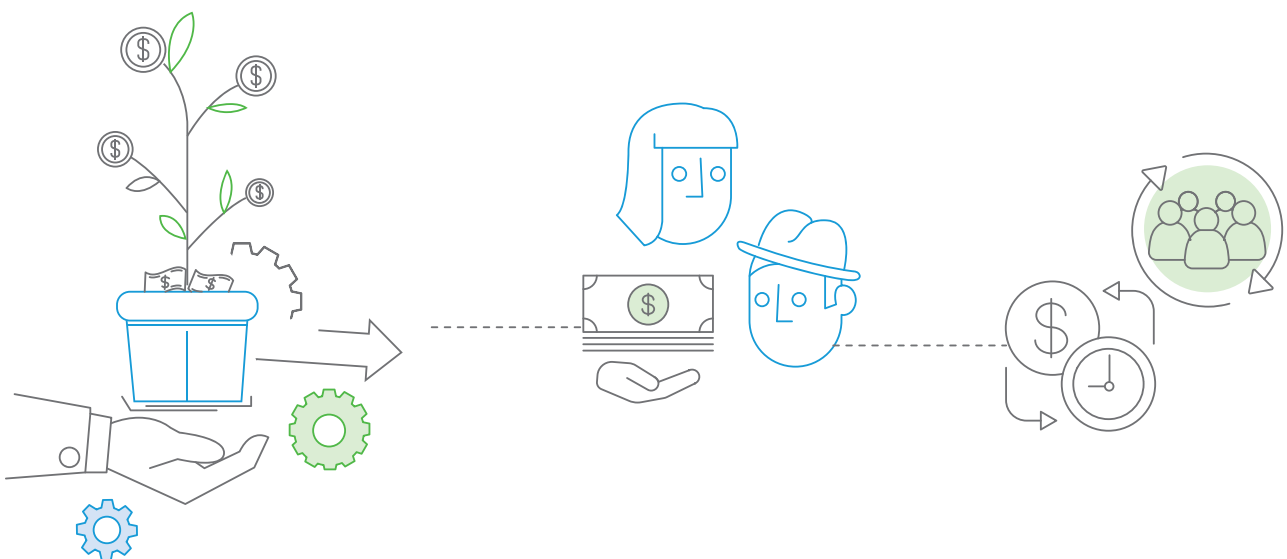
